
HARTIC HOMICIDE 6593 Moff Road, Atvator, Obio INVESTIGATIVE WORK PRODUCT 66190-2674



On Tuesday, April 28, 1992 at approximately 8:00 Chief Det. Duame Kaley and Lt. Don Doas of the Portage County Sheriff's Department re-interviewed one Terry Davis of 6593 Moif Read in Atvator, Onio. (947-3419). We were just stepping back to see if he had heard anything more in reference to the homicide that had occurred on C4-07-90. Terry said that he had heard a rumor about two blacks a while back that were supposed to have been the ones that committed this particular act. We also thought that we had apprehended them. We asked Terry who lived on the other side of the Nartigs and he said it was one Tom Leggett who has a boy 16 years old. Supposably Tom is diversed and has a daughter who lives with his ex-wife. We thanked him for his composation and gave him a numbers card, advising that if he heard any further information to give us a call.

After interviewing Terry Davia we stopped at the liggett residence at 6565 Moff Road and questioned him as far as any information that he might have available regarding the Martiq hemicide. Ten stated that he wasn't around the day that the police discovered the bodies of Cora and Bernhart Martiq. He indicated that they would talk every once in a while in the summer due to the fact that they would be out nowing their lawns or working in the gardens. During the vinter time he stated that they were not known to cone out much. We requested to know what weapons Mr. Liggett owned

and he stated he had a 22 cal. revolver, a 22 caliber rifle, and a twenty gauge whot gun. He also indicated that Bernhart Hartig would go for a walk everyday.

On Thursday, April 30, 1992 Chief Oct. Dwang Kaley and Lt. Don Doak met with Kieth Lovery of Polygraph Consultants at the Portage County Sherliff's Department. This was in reference to one Lawis Lahman who was to come ongatation and provide the aforementioned officers with photographs and figgerprints of himself. Once lawis labour arrived at the Partage County Sheriff's Department at Approximately 1000 hours. He was fingerprinted and photographed by Li, Doak. Alter this task was performed, Lawis was then questioned by Chief Det. Duane Baley and Lt. Don Doak in reference to any involvement he might have had in the homicide that had occurred on Moff Read in Atvator Township. He stated that he was familiar with Bernhart and Cora Bartig and that he had furnished supplies mind insurance to them. He remembers taiking to them a couple of months before theiridensee reference to their insurance policy. He indicated that they were a quiet couple and seamed very nice. He also indicated that when he would go to do business at the Hartig residence he would usually sit at the Etteben table which is where the homicide occurred. He stated that Mr. Harting would usually sit at the chair towards the kitchen door leading to the garage and Mrs. Hartig would wit at another location. He also indicated that he has been in the living room at one time or another. When asked shout the 25 semi automatic weapon that he used to cum, he again stated that he sold it to a individual but was unsure of who or where. The conclusion, Kaley requested Mr. Lehran to submit to a polygraph test. He stated that he was concerned as to their accuracy and it was his desire to consult with schools. before submitting to thet-type of test?
